She was wondering about her next steps. (20 marks, 250 words)

- What are the ethical issues and dilemmas that confronts the professor?
- What are the potential consequences of removing ambiguous data from the research report on both the scientific community and public health? Explain
- How should the professor balance the need for continued funding with the obligation to uphold ethical standards in research? Evaluate the possible longterm effects of compromising research integrity for financial support.
